Re: public records request

Dear Chancellor Thorp:

I write on behalf of UNC alumnus E. Vernon F. Glenn, of Mt. Pleasant, South Carolina, who obtained his undergraduate degree from the University of North Carolina in 1972. Pursuant to the North Carolina Public Records Law, G.S. § 132-1 *et seq.*, I request copies of the public records identified in the attached list. We believe that these documents are fully public and are not subject to any exemptions to the Public Records Law.

The NCAA investigation of UNC and its football program has been the subject of extensive public discussion. Likewise, your decision with regard to the termination of Coach Davis has been the subject of intense public discussion and scrutiny, both with regard to its substance and its timing. As you know, the law provides that even documents exempted from the Public Records Law by the State Personnel Act may be released when "the release of such information or the inspection and examination of such file or portion thereof is essential to maintaining the integrity of such department or to maintaining the level or quality of services provided by such department" G.S. § 126-24. Accordingly, and in keeping with the University motto *lux libertas*, we urge you to consider release pursuant to this integrity exception, even if you consider some of the requested records to be personnel records.

Although it is clear that an individual requesting public records need not disclose his reason for doing so, my client does not mind telling you why he makes this request. Unlike those individuals who have been identified in recent media coverage as considering a class action against the University, he has no interest in such a claim. He seeks information only.

We believe that we have limited our requests to a very specific category of records and narrow time period. In the event that copies of these records are not readily and immediately available, we request to be provided copies of records as they become available. We are happy to receive the documents in whatever medium is most convenient for you – hard copy or electronic – and of course we are happy to pay the actual cost of reproduction of the records.
